Erwin Hein, also known as Erwin E. Hein, and Lenora Hein, his wife, and in her own right... first part...

The Northwest one-quarter (1/4) of the Northwest one-quarter (1/4) of Section sixteen (16); also that part of the East one-half (1/2) of the Southeast one-quarter (1/4) of Section sixteen (16) lying Northerly of the State Road, so-called, except a parcel of land out of the East side thereof occupied as a cemetery site, all being in Township thirty-five (35) North, Range four (4) East.

The route to be taken by said lines of poles, wires, cables and conduits across, over and under said land being more specifically described as follows: Second party may locate said route on, over and across said above described land, along or adjoining as near as practicable a line, which said line is described as beginning at a point not more than 2000 feet nor less than 1400 feet West of the East line of Section 8, Township 35 North, Range 4 East, at a point not more than 400 feet North of the South line of said Section, running thence Southeasterly to a point not more than 100 feet West of the North and South quarter line of Section 16 of said Township at a point not more than 600 feet nor less than 300 feet South of the East and West quarter line of said Section, running thence Southeasterly to a point not more than 1200 feet nor less than 800 feet West of the East line of Section 15 of said Township at a point not more than 600 feet nor less than 400 feet North of the South line of said Section 15.

With full right and authority to the second party, its successors, licensees, lessees or assigns, and its and their agents and employees, to enter at all times upon said premises for the purpose of constructing, repairing, removing, replacing, patrolling, improving, enlarging and maintaining such cables, conduits and poles and other supports, with all necessary braces, guys, anchors, manholes and transformers, and stringing thereon and supporting and suspending therefrom lines of wire, cables or other conductors for the transmission of electrical energy and/or communication, and to trim, remove, destroy or otherwise control any trees and brush which may, in the opinion of said second party, interfere or threaten to interfere with or be hazardous to the construction, operation and maintenance of said lines. It is expressly understood that no buildings or other structures will be placed under such wires and/or over such cables without the written consent of said second party. It is expressly understood that non-use or a limited use of this easement by second party shall not prevent second party from later making use of the easement to the full extent herein authorized. Second party to pay at the rate of Eighty Dollars (\$80.00) per mile of length of the line of poles and wires across said above described premises, the same to be paid before any work is done on the land, and also to pay for any damage to crops in erecting and maintaining said line of poles and wires.
