Forever, the easement and right to erect, lay and maintain lines consisting of... poles, wires, cables, conduits and other fixtures and appurtenances for the purpose of transmitting and distributing electricity and/or conducting a communication business on, over, under and across the following described parcel... of land, including all public highways upon or adjacent to said parcel... of land, which parcel... situate in the TOWNSHIP... of... County of... and State of Michigan, to-wit: Part of Lot 3 Section 30, Town 36 North, Range 3 East, described as commencing at a point 33 feet N. 1 deg. 21 min. W of the corner common to Secs 29, 30, 31 and 32 thence N 1 deg. 21 min. west 822 feet along the line between Secs. 29 and 30; thence N. 87 deg. 45 min. west 318 feet; thence S. 84 deg. 53 min. W 103 feet; thence S 42 deg. 26 min. W 100 feet; thence S 58 deg. 4 min. W 222 feet; thence S. 74 deg. 25 min. W 133.4 feet; thence S 85 deg. 40 min. W 146 feet; thence N. 04 deg. 47 min. W 251 feet to the 1/4 line between Lots 3 and 4; thence S 1 deg. 21 min. E. 466 feet along said 1/4 line to a point 33 feet N. of the Sec. line; thence S 87 deg. 45 min. E 1320 feet to place of beginning.

The route to be taken by said lines of... poles, wires, cables and conduits across, over and under, said land being more specifically described as follows: Second party may locate sd. route on, over and across said above described land along or adjoining as near as practicable a line which said line is described as beginning at a point on the west section line of Section 30, Town 36 North, Range 3 East, and not more than 300 feet North of the Southwest Section corner of said Section 30, running thence Easterly to a point not more than 200 feet east of the North and South 1/4 line of Section 29, same town and range, and not more than 650 feet nor less than 450 feet North of the South Section line of said Section 29.

With full right and authority to the second party, its successors, licensees, lessees or assigns, and its and their agents and employees, to enter at all times upon said premises for the purpose of constructing, repairing, removing, replacing, patrolling, improving, enlarging and maintaining such cables, conduits and... poles and other supports, with all necessary braces, guys, anchors manholes and transformers, and stringing thereon and supporting and suspending therefrom lines of wire, cables or other conductors for the transmission of electrical energy and/or communication, and to trim, remove, destroy or otherwise control any trees and brush which may, in the opinion of said second party, interfere or threaten to interfere with or be hazardous to the construction, operation and maintenance of said lines. It is expressly understood that no buildings or other structures will be placed under such wires and/or over such cables without the written consent of said second party. It is expressly understood that non-use or a limited use of this easement by second party shall not prevent second party from later making use of the easement to the full extent herein authorized. Second party to pay at the rate of \$25.00 per pole placed on the above described premises, the same to be paid before any work is done on the land, and also to pay for any damage to crops in erecting and maintaining said line of poles and wires.
